NO.PAS/Legis-B-23/2011- The Sindh (Repeal of the Police Order, 2002 and Revival of the Police Act, 1861) Bill, 2011 having been passed by the Provincial Assembly of Sindh on 13th July, 2011 and assented to by the Governor of Sindh on 14th July, 2011 is hereby published as an Act of the Legislature of Sindh.

THE SINDH (REPEAL OF THE POLICE ORDER, 2002 AND REVIVAL OF THE POLICE ACT, 1861) ACT, 2011.

SINDH ACT NO. XXII OF 2011

AN ACT

to repeal the Police Order,2002 (Chief Executive's Order No.XXII of 2002) and revive the Police Act, 1861 (Act No.V of 1861).

WHEREAS it is expedient to repeal the Police Order,2002 Preamble. (Chief Executive's Order No.XXII of 2002) and revive the Police Act, 1861 (Act No.V of 1861), in the manner hereinafter appearing;

It is hereby enacted as follows:-

- 1.(1) This Act may be called the Sindh (Repeal of the Police Short title and commencement.

 Order,2002 and Revival of the Police Act,1861) Act,2011.
 - (2) It shall come into force at once.
- 2. The Police Act,1861 (Act No.V of 1861) as it stood on 13th Revival of Act No.V of 1861.

 August,2002, is hereby revived with immediate effect as if it had never been repealed.
- 3. The Police Order,2002 (Chief Executive's Order No.XXII of Order No.XXII of Order No.XXII of Order No.XXII of 2002.

 2002) to the extent of its application to the Province of Sindh is hereby repealed with immediate effect.

- 4. Notwithstanding the repeal of the Police Order,2002 (Chief Saving. Executive's Order No.XXII of 2002), all orders made (including rules, bye-laws, regulations and notifications and other legal instruments), proceedings taken, appointments made, acts done by any authority or any person, which were made, taken or done, or purported to have been made, taken or done thereunder, between the 14th day of August,2002 and the date on which this Act comes into force (both days inclusive), shall continue to remain in force, until altered, repealed or amended by the Chief Minister or any authority or officer, authorized by him.
- 5. If any difficulty arises in giving effect to the provisions of this **Removal of difficulty.**Act, the Chief Minister may, by notification in the official gazette, make such provisions as appear to be necessary or expedient for removing the difficulty.
- 6. The Sindh (Repeal of the Police Order,2002 and Revival of the **Repeal.** Police Act,1861) Ordinance,2011 is hereby repealed.
